- 2. That the school authority shall rever claim any financial assistance from State Govt.
- That the school shall be located in a relatively noise free and pollution free area having adequate supply of drinking water and electricity.

- That the school shall have classroom of adequate space commensurate with the enrolment which is comfortable and suitable for imparting lesson and not less than the number of class units.

- That the school shall have girls common room, if it is a girls or co-ed school, teachers room and adequate furniture.

- That the school shall not charge any capitation fee or equivalent to that by any means
- 19. That the funds raised by the school authority, the fees collected and income earned by any other sources shall not be utilized for any other purposes than the welfare of the school and benefit of education of the students and teaching and non-teaching staff of the school.
- 20. That the school shall have to furnish accurate and up-to-date statistical information relating to the functioning of the school and its academic activities as and when the same is called for by the Deputy Director of School Education (AIS), W.3.
- 21. That the service condition of the teaching and non-teaching staff including provisions of security of service, disciplinary proceedings and procedure for Appeal
